- 2. The artist agrees to make a donation of 20% of the sale on all work sold at the gallery to The Painting Center. If the artist is providing a work as a loan only and the work is not for sale, please indicate the insurance value on this agreement.
- 3. The Painting Center will insure all artworks against risk of physical loss and damage for the duration of the exhibition. The Painting Center has \$350,000 insurance coverage for all artworks.
- 4. All framing, shipping, and delivery costs will be borne by the artist. Installation of *The Blues* is the responsibility of Shazzi Thomas. Lisa Pressman and Kathy Cantwell. The exhibition will be installed on Sunday, January 26 at 12 pm.
- 5. The Painting Center requires that all works be ready to hang before it arrives at the gallery with wire attached to the works. All works on paper must be framed with hanging wire attached. All works shipped to The Painting Center must be packed adequately to ensure the safety of the works in transit, with clear instructions about repackaging the works for return shipment (do not include packing peanuts). Please include return shipping labels for all works.
- 6. Works can be delivered or shipped to The Painting Center from January 21 to January 25 between 11 am and 6 pm. If you are unable to send works during these dates, please make special arrangements with the gallery.
- 7. Works can be picked up from The Painting Center from February 25 to February 29 between 11 am and 6 pm. The Painting Center will not be able to store works after March 5. Works will be shipped back during this week with return labels attached.
